- WCAR Board of Directors meets on the third Thursday of each month at 9:00 a.m. Most meetings are approximately 2 hours' duration.
- Directors are required to attend the Fall Strategic Planning Retreat on October 2<sup>nd</sup> and 3<sup>rd</sup>, 2019.
- Directors are required to complete an Ethics course
- Directors are expected to attend and represent the Board at Membership Luncheons, Fund Raising Events, and social activities of the WCAR.
- Officers and Directors are strongly encouraged to make a significant contribution to RPAC.
- Agrees to support the Strategic Plan, By-laws, Policies and Procedures of the Association.
- Must have either served on a committee or task force within the past 5 years or must have completed WCAR Leadership Academy.
- Cannot serve concurrently as a REALTOR® Good Works Foundation Trustee.
